
Within 10 days from the date of this Order, defendant shall transfer to plaintiff any domain name owned by defendant that is similar to any of the above-listed marks. Defendant shall bear any cost associated with such transfer.

Pursuant to 15 U.S.C. §§ 1117(d) and 1125(d)(1), the Court awards to plaintiff statutory damages of \$20,000 per each domain name, "trendmakerhome.com" and "trendmakerhome.info", thus totaling \$40,000 in statutory damages. Pursuant to 15 U.S.C. § 1117(a), the Court finds this to be an exceptional case, and thus awards reasonable attorney fees to plaintiff in the amount of \$40,000. Within twenty (20) days after entry of this Order, defendant shall hand-deliver to plaintiff's lawyer a cashier's check in the amount of \$80,000, made payable to TMI, Inc.

Defendant shall file with this Court and serve upon plaintiff within thirty (30) days after entry of this Order a report in writing, under oath, setting forth in detail the manner and form in which defendant has complied with each of the terms of this Order.

It is so ORDERED.
